



# AKC Sanctioned 4 & Under 6 Months Puppy Competition

**Entry Fee: \$25.00 per puppy**

This is a recorded event by the AKC for the Certificate of Merit and Puppy of Achievement certificates.

## Section 1 - Classifications

The Four-to-Six Month Puppy competition shall be for dogs that are four months of age and over, but under six months on the first day of the event. Classes will be offered for breed and varieties and divided into Groups as described in Chapter 3, Section 1 of the Rules Applying to Dog Shows and the Miscellaneous Class breeds as listed in Chapter 3, Section 23. The Miscellaneous class competition will be the equivalent of Group competition and the winner will be eligible to compete in Best Four-to-Six Month Puppy in Show. The FSS competition will be the equivalent of Group competition and the winner will be eligible to compete in Best Four-to-Six Month Puppy in Show.

# AKC National Owner-Handled Series

**(Remember to check the box near the bottom of the entry form)**

The AKC National Owner-Handled Series is a non-titling competition for dogs that are exhibited by their owners that are not professional handlers.

Exhibitors must declare their dog is Owner-Handled eligible at the time of entry on the entry form.

Dogs entered in the Amateur-Owner-Handler class will automatically be marked as eligible to compete in the NOHS.

Eligible dogs will be identified by an asterisk in the judge's book, steward's book & the catalog. Dogs must be handled throughout the breed level competition for the regular show by an eligible owner.

Professional handlers\*, household members and current assistants\*\* to professional handlers may not exhibit the dog in any NOHS competition during the entire show. For a detailed description of the National Owner-Handled Series, please visit the AKC website NOHS pages at:

*\*Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years.*

*\*\*A current assistant is defined as anyone employed by a professional handler on a full-time basis or assisting a professional handler at the show or any time during the cluster/weekend. Current assistants that are eligible to compete in Junior Showmanship (meet age & amateur status requirements) may participate in NOHS.*

***NR1.08100.15000.* Veteran Classes - (FOR ALL BREEDS - EACH DAY)** Class for intact dogs and class for intact bitches 7 years and over.

***NR1.08200.* Hunting Classes - (VIZSLAS ONLY - FRIDAY & SATURDAY)** - Class for intact dogs & class for intact bitches that have earned the title of Senior Hunter or Master Hunter.

***NR1.08500.* Field Trial Classes - (VIZSLAS ONLY - FRIDAY & SATURDAY)** - Class for intact dogs & class for intact bitches that have a placement or a Judge's Award of Merit for an AKC Licensed Field Trial. Please have proof of FT placement or JAOM with you day of show.

### SPECIAL ATTRACTION CLASSES INVOLVING MULTIPLE DOG ENTRIES (FOR ALL BREEDS - EACH DAY)

***NR2.09100.* Stud Dog Class** - Will be for Stud Dogs and two of their Get. Stud Dogs must be entered in the Stud Dog Class and must be shown in the ring with their Get. Owner of Stud Dog need not necessarily be owner of Get. Get only to be judged based on the merits of the Get. Get MUST be entered in one of the Regular Classes. While the merits of the Stud Dog are not to be considered in the placement of the entry, the Stud Dog must be examined to determine if it has a condition that would require its disqualification or excusal under the Dog Show Rules, AKC policy or the standard for its breed.

***NR2.09200.* Brood Bitch Class** - Same as Stud Dog except substitute Brood Bitch for Stud Dog and Produce for Get. As the judge's decision in the Stud Dog and Brood Bitch Classes will be based on the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in the class will be eligible for Best of Breed or Variety by virtue of having won these classes.
